



Fifth Expotrastiendas Photography Contest

Senseless?

Rules and Conditions:

Contestants:

The contest is open to Argentine and foreign amateur and professional photographers over 18 years of age. Foreigners must have resided in Argentina for more than five years.

Relatives of the jury and staff or senior management of Expotrastiendas, AAGA, Fundación Luz Austral or Fundación Andreani are not eligible for the contest.

By entering the contest, contestants fully accept these rules.

Receipt of the Material:

Expotrastiendas will accept entries from April 3 to May 3, 2009.

In all cases, photographers may submit up to 6 images printed on the following material:

Color or black and white photographic paper with a maximum size of

15x20 cm. Each artwork shall have the following details on the back: author's first and last name, address, zip code, telephone number, e-mail address and work title (if applicable; otherwise, write Without/T).

The material shall be delivered in person or mailed to Suipacha 1087 3º "B" C1008AAU, Ciudad Autónoma de Buenos Aires, in a closed envelope.

Fundación Andreani has arranged that Correo Andreani will provide contestants with a Pre-Paid Postal Reply (PPR) to mail the contest material free of charge. Envelopes posted in any Correo Andreani postbox (see Instructions for PPR Use at the end of this document) until May 3 2009, inclusive, will be accepted.

Selected Artworks:

Selected artworks will be published on our website www.expotrastiedades.com.ar as from May 26, 2009.

Selected contestants shall submit their selected artworks printed on 50 cm x 60 cm photographic paper.

Contestants will be solely liable for the content of the submissions. Although Expotrastiedades will take all the necessary precautions in terms of the preservation and safety of the received artworks, it shall not be liable for any damage or deterioration caused involuntarily. Expotrastiedades will not take out any insurance on the artworks, their transportation or for any other reason.

Jury:

Entries to the 5th Expotrastiedades Photography Contest will be judged on May 15, 2009.

The jury will be comprised by Ana Martínez Quijano, Pelusa Borthwick, Alejandro Montes de Oca and Fabiana Barrera as an invited artist.

Expotrastiedades shall be able to replace those jury members who cannot fulfill their tasks due to compulsory reasons.

Jury's decisions are final.

Prizes:

There will be 3 acquisition prizes for \$2,000 (two thousand Argentine pesos) each, plus one special jury recognition and three honorable mentions.

Exhibition:

Some artworks will be selected for exhibition; they will compete for the

three acquisition prizes, the special jury recognition and the three honorable mentions.

Expotrastiendas will take all the necessary precautions regarding the safety and protection of the artworks but it will not be liable for any potential robbery, damage or theft.

Acceptance:

Every entry failing to meet the conditions described herein will not be accepted. Entries submitted after the submission deadline will be rejected.

Expotrastiendas reserves the right to accept entries and to establish the scope of these rules, its decision being final.

Rights:

By entering the contest, the contestants authorize Expotrastiendas to exhibit their works in the way, places and time it decides, as well as to reproduce them on promotional and press material related to the contest, mentioning the author's name in every case.

Entrants retain their copyrights to their submissions under Law N° 11,723, granting only the authorization to publish them.

Return of Artworks:

Authors are responsible for removing those artworks on display which do not receive a prize, and they will be able to do so once the exhibition is over, on the dates announced by the organizers in due course.

The entries which have not been selected shall be removed from Expotrastiendas' offices within 30 days after receiving notification. Otherwise, Expotrastiendas will be able to dispose of them.
